**Room Reservations:** The following accommodations located at Summit Village are reserved:

**Rates:** Per adult per stay, based upon the number of adults in each accommodation. Package includes: (2) night of lodging, (2) breakfast buffets, (1) dinner banquet, Friday Night Welcome Party, Weekend Superticket and Nordic Pass, (and daycare for children not skiing) complimentary night skiing on arrival day on Summit Slopes, applicable state tax and resort fee, dining gratuities, **up to 8 hours instruction for Alpine, Nordic, Snowboarding and Telemark** in conjunction with the **Instructional Clinics.**

**Special Notes:**

1. One complimentary adult package for every 30 adult packages paid, (average rate) when all packages are billed to one master account.
2. **If rental equipment is needed for Telemark lessons a form must be filled out prior to arrival to reserve equipment.**

**Minimum Group:** Rates quoted are for participation in the **Instructional Clinics.** A change in date will result in a rate change. Unused portions of the package are not refundable.

Check-In: Guaranteed at 6:00 pm. Check-Out: Check-Out is at 2:00 pm.

**Lodging Reservation Method:** Jug and Mug Ski Club will provide a rooming list and second deposit of \$30 per person, by December 5, 2006. Rooming list shall include the following information for each individual: Name, Age (applies to children under 17 years only), arrival and departure dates, type of accommodation, and individuals who will be sharing a room as well as skier type and ability. Example: racer, recreational, snowboarder, cross country or child. Level: advanced, intermediate, beginner or never skied before. **Any adult wishing to remove lessons from the package must be listed as such on the rooming list and they will receive a \$20 discount off the package. No refunds will be given upon or after arrival for any portion of the package.**

After the agreed date of December 5, 2006, any accommodations for which Shanty Creek has not received a deposit or written guarantee will be released to general availability, A written guarantee is defined as a letter from a company/club officer guaranteeing payment for rooms reserved.

**Attrition Clause:** Within 30 days of arrival, reductions in the number of individuals or no-shows will result in forfeiture of the individuals' second deposit.

**Billing:** All package charges are posted on (1) master account to be paid upon departure by trip chairperson in full. Charging to individual rooms is not allowed. If there are any room charges, they will be applied to the ski club's master account and paid upon departure. If there are any unpaid charges after (30) days, a late fee of 1.5% per month will be added to the balance.

**Damage Warranty:** The group contact person, with Jug and Mug Ski Club is responsible for the conduct of the group. Individuals and/or the Ski Group will be financially liable if there is any property damage by any member of the group.

**Event Details:** If rental equipment needs are in excess of (15) pair, please make prior arrangements with your ski club coordinator.

**Skiers Responsibility Code:** The purchaser and user of a Shanty Creek ski lift ticket assumes and understands that skiing is a hazardous sport, and that bare spots, variations in snow, ice and terrain along with bumps, moguls, stumps, forest growth and debris and rocks and many other hazards or obstacles exist within this ski area. In using the ticket and skiing at the area, such dangers are recognized and accepted whether they are marked or unmarked. The skier realizes that falls and collisions do occur and injuries may result and therefore assumes the burden of skiing under control at all times.


**Written Notice:** Upon written notice, either Jug and Mug Ski Club or Shanty Creek may be excused from performing this agreement due to acts of God, war, government regulation, disaster, strikes or civil disorder, making it illegal or impossible to provide the facilities or hold the outing.

**Signatures:** The undersigned represents and warrants that he/she is duly authorized and appointed agent for Jug and Mug Ski Club, fully empowered to bind the outing to all provisions contained in the agreement, and that no further action is required on his/her part to enter into this agreement.



Second deposit of \$30 per participant due December 5, 2006.

### Miscellaneous:

If 30 people sign up, we will get one comp. There have never been 30 before but if there are, the comp will go to the Club Treasury.
